I. Welcome Remarks New Member Welcome

Denise also announced that a subcommittee will be formed to review the requirements of the scholarship, including repeat recipients. For this year, it was determined by the Steering Committee that the scholarship could be awarded to the previous recipients.

VI. Managing the Challenges of Change as a Manager

Denise presented an interactive session that provided an overview for managers on how behaviors and beliefs can influence a team's successful adaption to and adoption of change initiatives.

There was a large group discussion, break out rooms, and time for sharing the break out room discussions.

The framework for the large group discussion included the following topics:

- What can we do to support each other?
- Knowing and understanding ourselves
- Knowing that we can't manage what's happening but we can manage ourselves

Denise shared a video from LinkedIn about Managing Change and an additional document with various resources. One resource is The Change Cycle book, which is available in HR and the Cheng Library for loan or can be purchased by the departments.

Some comments following the video were:

- Managers should build trust;
- Find colleagues to help you work through issues;
- Think about how we navigate ourselves to model the behavior managers want to see from the team;
- Look for the good where we are hoping the change will lead us

Select points from the break out room share out session were:

- Built and have trust, communication, and transparency with your team; be accessible
- Create a safe space for employees, especially because the new, different, and unknowns may make it uncomfortable for some employees
- See the longer term picture the benefit of change once the expected goal is reached (work or personal)

- Empower employees/team to use their skills or learn new ones; push them out their comfort zone
- Make sure employees have soft skills
- Communicate about the "why"

VII. What's next for the DC?

Denise Robinson Lewis, Chair Liana Fornarotto, Vice Chair

Denise and Liana asked the membership to share ideas about how the DC can move forward and better foster collaboration between Directors. One thought is to expand civic or community engagement.

Ideas presented by the membership were:

- Mentoring for new Directors Denise noted this is something that Gamin had wanted to do when she was Membership and Engagement Chair;
- Technology that could be used to help foster collaboration;
- Department sharing of activities members could ask questions about other department's functionality, etc.
