## The important issues for us to focus on are:

1. What we need to ask? - approach

2. How to collect the data? - venue

We should break up to small groups to gather the information, go to our departments and colleges to get the relevant information.

What should we gather - concerns and the positive suggestions, how technology on campus works for you?

We were satisfied with a focus group approach - convincing faculty participate is the issue.

Survey approach:

If we want to use a questionnaire we should provide possible answers.

Can the questionnaire be embedded in the email? - Bb survey can be used, and it can be sent to faculty via email embedded as a link.

But there is still the problem of low response rate

#### Focus groups approach:

Conducting focus group interviews - coming up with a list of questions with specific topics The purpose is to ask faculty to respond to the approach of the university that wants to develop online programs We will collect data from our departments and colleges to collect concern and other comments We should record the responses from the faculty

What exactly do we want to ask the departments?

1. University strategic plan contemplates creating a number of online programs (selected programs)

2. We, the faculty, will be teaching these courses and given that fact, how do you invasion it as working from the faculty perspective?

Can you address the following issues?

- Faculty training/readiness,
- Library resources to support it.
- Intellectual property,
- Quality control,

- Student readiness
- Academic integrity

3. The information should be collected from (1) faculty that do not teach online at this time and did not do so in the past and (20 faculty that teach online

4. Faculty should not feel responsible for the technology - they will get support from the IT department
