Year End Report (2014-2015)

The council convened and received charges on September 23, 2014 (Susan Dinan and Nina Trelisky were present). Susan Dinan read the 2014-2015 charges to the council.

The council decided that because there was not a quorum present at the first meeting, nominations for a chair would take place electronically. The council voted to elect Yvonne Roux and Sue Mankiw as cochairs.

During the previous academic year (2013-2014) the undergraduate council reviewed the "blue form". The council decided to invite Nina Trelisky to our first meeting in Fall 2014, to discuss potential changes to the forms. Nina joined us at the September 23, 2014 meeting. The following summarizes the discussions and actions that took place:

- Nina Trelisky demonstrated an upcoming electronic version of the course change proposal form.
 It was agreed that making this form available electronically would benefit all parties. The council shared their suggestions as listed in the final 2013-2014 council year-end report. Nina informed the council that Degree Works will be fully operational in Fall 2015.
- The council discussed how many credits constitute a minor. Since the undergraduate catalog states most minors consist of 18 credits, this was the minimum number. Also, one course can be a lower level course in keeping with currently approved minors in Psychology, Anthropology, Sociology and Philosophy. This question directly related to the proposal submitted for the Italian & Italian American Studies minor.
- The council discussed the maximum number of courses that can meet both UCC and major core courses in a major. Deborah Sheffield had reached out to Maggie Williams (UCC council) and in areas 1,2 and 3- three courses is the maximum number. This questions directly related to the program change in the B.A. Geography.

In addition, the Council met electronically on a regular basis through e-mail and the council Bb.

All of the above mentioned proposals were successfully approved by the FS.

There were no pending proposals awaiting the UG council's review at the end of the 2014-2015 academic year. We attribute this phenomena to the new proposal submission deadlines put in place for inclusion in the 2015-2016 catalog.
