## 2. STUDENT REGISTRATION

Register for courses by going to <http://www.wpunj.edu> > WPCONNECT-log-in-Student(Tab)-My Registration-Add/Drop Courses

View your advisement, courses, tuition, transcript, etc.

- **What is a pin #?**  
The alternate pin # is your six-digit birthdate **MM/DD/YY**
- **When are courses available?**  
The on-campus program offers courses in **spring, fall, and summer** semesters.  
(theory and clinical). The WP Online program offers courses every 7 weeks. Click on link to **Look up course offerings**.
- **What hours are the courses available?**  
All graduate nursing courses are offered during the **evenings** Monday through Thursday beginning at 5pm. Most of the courses are face to face or hybrid and a few fully online. The WP Online program is fully online except for the practicums, which are in an outpatient clinical setting.
- **What courses do I begin with?**  
All new students are advised to register for any of the following **graduate core courses** -NUR 5001 *Theoretical Foundations*, and/ NUR 5461- *Adv. Pathophysiology*. **If you can only enroll in one course, register for NUR 5001 where an orientation and other resources are discussed as you move forward in your graduate studies.**
- **When can I register?**  
**Registration timetables** (Click on semester tab)
- **How to change my program concentration** (Track: AGNP, FNP, ADT, EDT)?

- **How do I know I am cleared for a clinical course?**  
If, **all** preceptor documentation is confirmed and completed. Log onto Exxat and check to see if all documents that needed to be uploaded have been approved.
- **How do I check my clinical health clearance?**  
Log onto Exxat and check the status of the documents uploaded. You will see pending review, approved, and not approved. Exxat will provide comments if documents are pending and/or not approved.

### 3. TRANSFER CREDIT POLICY

---

A **maximum** of up to 49% **credits** from other institutions may be credited toward a master's degree program provided that:

- 1) Student applies for transfer credit at the time of matriculation
- 2) Work was taken in graduate courses for graduate credit
- 3) Work was taken within the last six years
- 4) Grade received was B or better
- 5) Work does not duplicate any work, graduate or undergraduate, for which credit was previously given
- 6) Work was not applied toward an academic degree at any other institution
- 7) Work was taken at an accredited college or university; and
- 8) Work is applicable to the student's program.

A current matriculated William Paterson University student may, in some instances, be allowed to take courses off-campus at other institutions as a visiting student and transfer the credit to William Paterson University. The student must receive permission from the dean of the college and/or the department chairperson of his/her program of study prior to course registration. These credits are allowed as transfer credit; provisions two through six as stated above remain applicable in such instances.

## 4. ADULT GERONTOLOGY NURSE PRACTITIONER IN PRIMARY CARE

The adult gerontology nurse practitioner (AGNP) track is a **39-credit program** that can be completed as a **full-time or part-time** student. In addition to the supervised clinical hours, a 2 ½ hour seminar (face to face/online/hybrid) will be held bi-weekly during the semester. Upon completion of the theory and practicum course requirements, you would be eligible to apply for the Adult Gerontology Nurse Practitioner in Primary Care Certification examination by American Association of Nurse Practitioner (AANP) or American Nurses Credentialing Center (ANCC).

- The pre-requisite courses for clinical practicum include completion of the graduate core, **3 P's** (6001-adv. health assessment, 5461-adv. Patho, 6011-adv. Pharm) and at least one of the advanced nursing specialization courses.

## 5. FAMILY NURSE PRACTITIONER

The family nurse practitioner (FNP) track is a **47-credit program** that can be completed as a **full-time** or **part-time** student. FNPs provide comprehensive primary health care services to individuals from infancy through adulthood. FNPs are prepared to provide care to individuals with acute and chronic illnesses. Preventive health services, patient education, disease management, and illness prevention are provided within the context of family and community. Upon completion of the theory and practicum course requirements, you would be eligible to apply for the Family Nurse Practitioner Certification examination by American Association of Nurse Practitioner (AANP) or American Nurses Credentialing Center (ANCC).

- The pre-requisite courses for clinical practicum include completion of the graduate core, **3 Ps** (6001-**adv. health assessment**, 5461-**adv. Patho**, 6011-**adv. Pharm**) and at least one of the advanced nursing specialization courses.
- In addition to the supervised clinical hours, a 2 ½ hour seminar (face to face/online/hybrid) will be held bi-weekly during the semester

## 6. NURSE ADMINISTRATION

**Only offered through WP Online.** The nursing administration track (ADT) is a **31-credit program** that prepares a nurse administrator to work in a variety of health care environments. Nurse administrators often manage a team of nurses, or a specific nursing unit or shift. Nurse administrators can interact directly with patients but are often assigned to a managerial role. A unique feature of the program is the ability to enroll in **six MBA courses** offered through the Cotsakos College of Business.

The program is designed for either **part** or **full-time** study. Upon completion of the theory and practicum course requirements, you will be eligible to apply for the Nurse Executive, Advanced Certification Examination by American Nurses Credentialing Center (ANCC) or the American Organization of Nurse Executives (AONE) administrator certification exams: Certified Nurse Manager and Leader (CNML) and Certified Executive Nursing Practice (CENP). The type of certification is based on experience level. In addition to the supervised clinical hours, a 2 ½ hour seminar (face to face/online/hybrid) will be held bi-weekly during the semester.

## 7. NURSE EDUCATION

**Only offered through WP Online.** The nursing education track (EDT) is a **35-credit program**. This program is designed for professional registered nurses who want to teach the next generation of nursing students or nurses. Nursing education takes place in diverse settings; including technical schools, hospitals, two-year colleges, four-year colleges, and universities. Students in this program complete theory and practicum course in order to be eligible to take the Certified Nurse Educator (CNE) or Clinical Nurse Educator examinations (CNE-cl) (National League for Nursing-NLN). The Masters in Nursing Education Program requires **215** practicum hours.

Students in the Post - Masters Certificate Program will complete the necessary theory and practicum course requirements in the track in order to be eligible to sit for the Adult Gerontology Nurse Practitioner in Primary Care certification examination (American Association of Nurse Practitioners or American Nurses Credentialing Center).

Students in the certificate program will complete the necessary theory and practicum course requirements in this track in order to be eligible to sit for the Nurse Educator certification examination (National League for Nursing or American Organization for Nursing Leadership).

## 12. MSN SCHOOL NURSE

---

The MSN in School Nursing is a 33-credit graduate degree program. This concentration focuses on assisting school nurses in expanding their knowledge, value, and skills in school nursing. The **33-credit** program consists of 24 credits of the school nurse instructional program and 9 credits of graduate core courses in the Department of Nursing. The student is also eligible for the Educational Services Endorsement as a certified school nurse when the 24 credits of the school nurse program is completed. Eight courses (NUR 5500, NUR 5510, NUR 5021, NUR 6170, NUR 5520, CSP 5601, SPC 5010, and PSY 6830) are needed to complete the New Jersey School Nurse Instructional Certification. Ten courses are either face-to-face, online or hybrid, one course, NUR 5520, is in the field (school health office and classroom).

3. A course in Developmental Psychology and a course in Public Health Nursing
4. Undergraduate GPA of 3.00 or higher

## 13. CLINICAL PRECEPTOR INFORMATION

- 1) Student must be authorized by their advisor to take a clinical course
- 2) Student must be **registered** for a clinical course (NUR 6041, NUR 7011, NUR 7070, NUR 7252, 7253, 7254, 7255)

- 3) Fill out **Student/Preceptor Information Request** form, transfer info in Exxat. On-ground program - Deadlines: **Spring - Jan. 2, Summer- April 30, Fall- Aug 1.** WP online program Deadlines: **Sp-1 Sept. 30, Sp-2 Nov. 30, Sum-1 March 30, Sum-2 April 30, Fall-1 May 31, Fall-2, July 31.**

All preceptors need to submit their cv/resume. The student needs to upload a copy in Exxat. Make sure **NP preceptor** includes their **certification and expiration date** for AANC or AANP on their **cv/resume** or **provide a copy of their certification**. If this is not provided, the request will not be approved until appropriate information is uploaded in Exxat.

- 4) The coordinators will review and approve/deny submissions. The student will be notified through Exxat when requests are approved/denied or if further information is required
- 5) Student must fulfill **health clearance requirements** (compliance documents) in Exxat by due date listed for each semester, listed on Graduate Nursing website under **clinical**.

**All clinical clearance documentation requirements are due 14 days prior to the start of the clinical course.** *\*If a student is not cleared 7 days prior to the start of the first day of their clinical course, they will be administratively dropped without warning.* **NO EXCEPTIONS**

Fill out **initial health clearance** (1<sup>st</sup> practicum) form or **re-clearance health form**. *Physicals must be completed annually*

- 6) Student must complete **background check** with **Universal (on Exxat)**. *Background checks must be completed annually.* Rechecks are only done when the initial check is going to expire or has expired. *Anyone who lives in New York State or who has lived in New York State in the last 7 years must complete a New York background check in addition to the one in New Jersey. A student may also be requested to complete a NYS background check if an alert comes up even if they have not resided or worked in NY in the last 7 years.*
- 7) Student must complete **urine/drug screening** with **Universal (on Exxat)**. *Urine/drug screening must be completed annually.*

**NP students:** A minimum of at least **one** clinical practicum must be precepted by a **Nurse Practitioner** (NUR 7252 & 7253 **MUST** be with an NP preceptor).

### How do I obtain a preceptor?

Students are encouraged to initially seek out preceptors early in the program. Students can seek out sites and/or practices with an NP or MD. **Tips for finding a preceptor**

**DO NOT CHOOSE:** A specialty focused practice, such as: hematology, oncology, surgery, respiratory health, etc. These practices do not provide the diversity of young adult, adult and older adult health problems required for certification. Emergency Departments are not appropriate for practicums.

### Clinical Requirements for NP Students

- Collecting patient histories and performing physical examinations on young adults, adults and older adults; (NUR 7070 – pediatrics and childbearing women).
- Identifying normal vs. abnormal findings in these populations.
- Recognizing and identifying common health problems of young adults, adults and older adults; (NUR 7070 – pediatrics and childbearing women); that can be of an acute, transient nature and chronic health problems)
- Developing and implementing management plans that include appropriate diagnostics and proposed treatment approaches.
- Prioritizing, organizing, managing and evaluating patient’s health care.
- Settings where young adults, adults and older adults, (NUR 7070 – pediatrics and childbearing women) receive health care are therefore an essential part of selecting a site. Your first site (NUR 6041) would ideally emphasize enough history and physical exams to establish confidence. Helpful settings might include Employee Health Services, Assisted Living Facilities, Nursing Homes, or Occupational Health departments in businesses or institutions.
- Consider settings that offer guaranteed opportunities to practice with young adult, adult and older adult clients, (NUR 7070 – pediatric and childbearing women); and within that category, these patients/clients should be represented: male and female patients with common health problems (acute and chronic), female patients with female specific health issues (GYN/GU). Settings might include: Internal Medicine Offices, Outpatient Medical Clinics, etc.; (NUR 7070 – pediatrician offices/clinics, Obstetric offices/clinics, etc.).
- White lab coats are required for all MSN students in the clinical practica- Contact:

We have three graduation dates for the **on-campus program**: January *25* (fall), *May 25* (spring), and *September 1* (summer). For **WP Online program** we have six graduation dates: November *1* (fall-1), *January 25* (fall-2), *April 1* (spring-1), *May 25* (spring-2), and *July 31* (summer-1), *September 1* (summer-2). For a student to graduate, they must fulfill their requirements, such as completing all their credits in their major, satisfying financial obligations, and applying for graduation. Any student who misses the deadline can apply for the next semester's graduation. Disregard the comprehensive requirement as this does not apply to nursing students. Official transcripts will not be available until 6 weeks after the graduation date (degree conferral date).

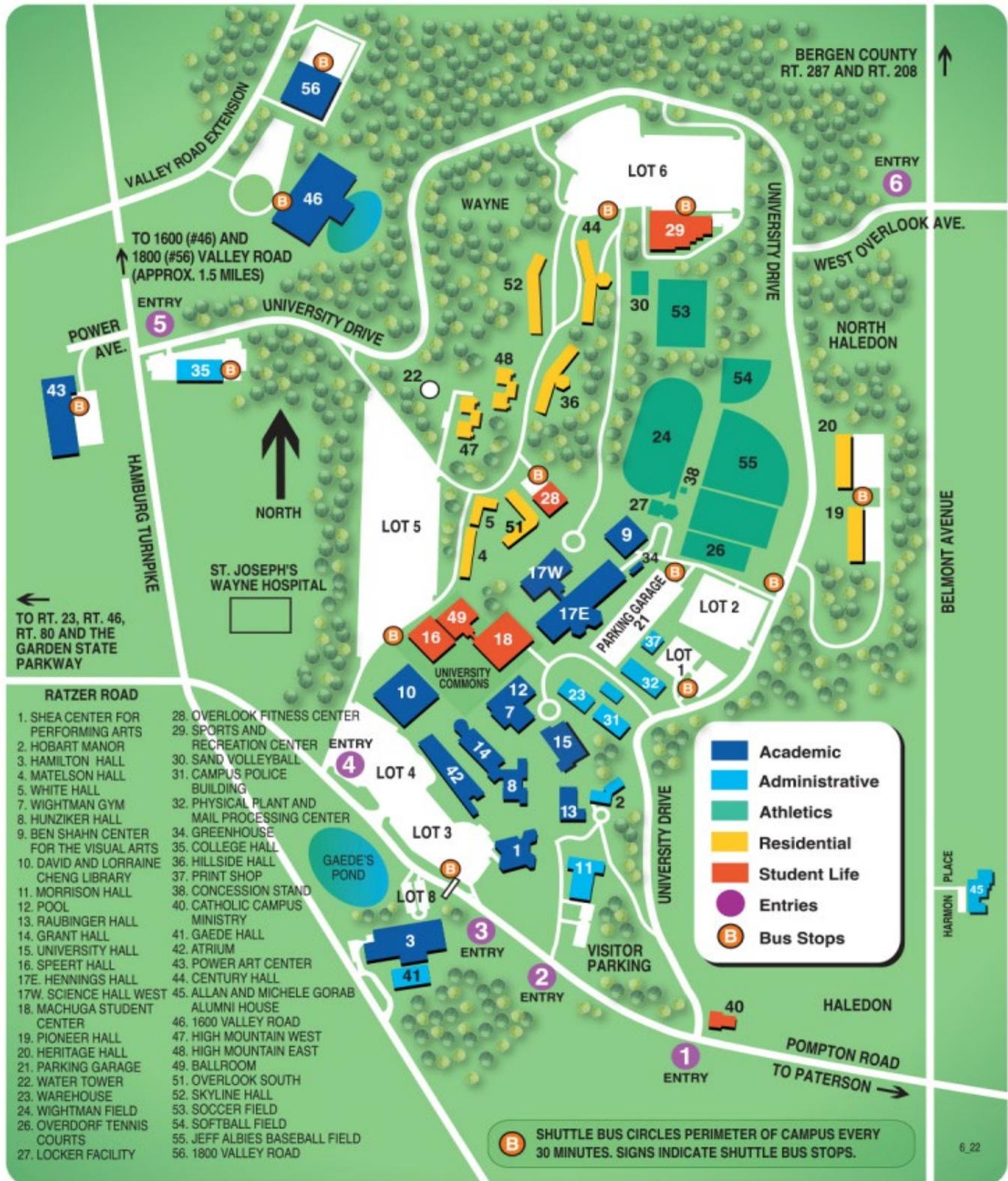
