co-Founder, Institute N.H.I. (No Humans Involved), a 501(c)3 educational non-profit organization and research institute established in 1993. The institute is no longer operative.

The acronym “N.H.I.” / “No Humans Involved” was a symbolic code deployed by members of the Los Angeles (California) Police Department for cases involving impoverished inner-city, Black and Brown males. The code was also deployed by members of the San Diego (California) Police Department in cases involving the murder of impoverished, Black and Brown female “street prostitutes.” Institute N.H.I. aimed to rethink the formation and replication of our contemporary world-system and its interwoven socio-human, ecological, and environmental crises. The Institute positioned itself within the context of an emerging, global, and *species-oriented* counter-culture of the human, exploring and proposing new ways of knowing/feeling/behaving/organizing — i.e. of *being human* — necessary to make possible the realization of this planetary and ecumenical humanism.

The Carter G. Woodson Circle

The Carter G. Woodson Circle by Institute N.H.I. was a bi-weekly workshop whose purpose was to provide a space for students, scholars, activists, and others to rethink the formation and replication of our contemporary world-system and its interwoven socio-human, ecological, and environmental crises. The circles explored and put forth new ways of knowing/feeling/behaving/organizing — i.e. of *being human* — necessary to resolve these interwoven crises by making possible the realization of a new planetary and ecumenical humanism.
