3. Charges for Elections Council, 2010-2011

Standing Charges [completed]

1. Develop standardized procedures for all campus-wide elections.

The Election Council's standardization of procedures continued the fall's 2009 election practice on offering a single election for the following committees:

- University Promotion Committee, (UPC)
- University Faculty Range Adjustment Committee (UFRAC)
- Professional Staff Promotion Committee (PSPC)
- Sabbatical Leave Committee
- Assigned Released Time Committee (ART)

Also, the council continued to send out two different calls for nominations: one for Faculty and another one for Professional Staff.
2. Conduct Faculty Senate elections prior to April 30.

Elections were held for the Professional Staff Representative and the four At-Large Representatives in April 2011.
3. Conduct campus wide elections according to the election policy for:
a. University Promotion Committee (UPC), Sabbatical Leave Committee, University Faculty Range Adjustment Committee (UFRAC), Assigned Released Time Committee (ART), and the Professional Staff Promotion Committee (PSPC)
$\rightarrow$ Elections for five committees were held in Fall 2010. The election for Adjunct Faculty representative was completed in Fall 2010, which is held in every 2 years out of sync with the general election.
b. University wide ad-hoc committees and major Search Committees where broad elected representation is needed. These elections can be called upon request from the Senate directly or by the Senate at the request of University Administrative officials for members from Faculty, Librarians, Professional Staff, and Adjunct Faculty.
$\rightarrow$ There was no request for ad-hoc committee elections during 2010-2011.
In accordance with the standing charges, the Elections Council coordinated a Fall Election for five different Committees, Adjunct faculty representative election, and the Senate General Election. Elections were held utilizing a web-based electronic voting system and the campus email and announcements systems were used for notification of all election related information.

ii. University wide ad-hoc committees and major Search Committees where broad elected representation is needed. These elections can be called upon request from the Senate directly or by the Senate at the request of University Administrative officials for members from Faculty, Librarians, Professional Staff, and Adjunct Faculty.
