- b. Combination of Council, Senate and Department approach will need to be created
- c. Provost has expressed his support of the document. Promotes the creation of a UCC Assessment Chair
- d. Recommendation that a sub-council work to establish a timeline and process for UCC course review
- e. Recommendation that Outcome 1 and Outcome 5 are the first to be reviewed
- f. Recommendation that there are separate reviews of the SLO's and the program courses. Also ensure that it is not assessing faculty
- g. Recommendation to try and create some common assignments to assess in various courses
- h. NSSE questions have been added to the working draft
- i. Discussion of rubrics recommendation to create or utilize standard rubrics to review general areas (e.g. oral communication, written communication, etc...)
- j. Recommendation to review UCC outcomes and program outcomes try to streamline language and establish common definitions to standardize program and UCC assessments
- k. Recommendation for faculty participation in assessment processes knowledge of subject matter is a critical component, faculty are also important to the development of a timeline and the coordination of the assessment
- I. Recommendation to include Review Panels to collaborate and potentially facilitate some of the assessment process
