This letter and my curriculum vitae are offered in response to your advertisement to join the William Paterson University as the Dean of the College of Science and Health.

I am currently the Associate Dean for Faculty Affairs in the College of Medicine at Charles Drew R. University of Medicine and Science. I also hold the academic rank of Professor of Otolaryngology. My career has been focused on serving, or teaching others to serve, the underserved of this and other communities.

The following are examples to highlight some of my accomplishments in specific areas:

#### **Academic Administration:**

Four years ago, I left Martin Luther King Jr. Hospital where I had been Chief of Communication Sciences and Disorders since 1980 to assume a full-time position in the medical school as the Associate Dean for Faculty Affairs. I have responsibility for three primary areas: Academic Personnel, Faculty Development, and Continuing Medical Education. One of my tasks was to rebuild the faculty of the College of Medicine after the closure of hospital. Through a collaborative process with faculty, college of medicine leaders, and also input for the leadership of the College of Science and Health, we redesigned the definitions and criteria for faculty appointments and promotions to fit our new environment where the faculty were no longer located in a single hospital, but rather distributed across Southern California. Academic series were realigned to accommodate the new environment. We also developed a metric for evaluating faculty contribution to the college. All faculty who wished to remained affiliated with the College of Medicine were given 1 year to submit an undated dossier for review by the Appointments and Promotions Committee. At the end of the 2008-2009 academic year, 160 faculty submitted documentation and had been successfully aligned into the new system. Currently, 100% of our 176 faculty have undergone peer-review and evaluation.

Two years ago, in collaboration with the Office of Community Engagement, we established a faculty track in our Prefix Series to bring our community partners onto the faculty. This

track not only solidifies our relationships with our community partners, but also provides a vehicle for the community to inform the College of Medicine about clinical and research needs as well as curricular content.

The medical school adopted a distributed model (using multiple hospitals and clinical sites in the community rather than a single teaching hospital) for delivering medical education. We believe that faculty development is a critical aspect of this new system. We have a strong commitment to teaching, not only the discipline specific content, but also to produce mission-focused graduates. As an integral component of this process, 36 months ago, we restructured the Office of Faculty Development. A strong program for existing and new faculty was developed and implemented to define, deliver and evaluate our mission-based curriculum. To date, nearly two-thirds of the College of Medicine faculty have participated and completed the initial faculty development program. Some have also participated in faculty learning communities and/or completed more advanced faculty development activities. In the future all faculty will be required to participated in some faculty development activity annually.

When I assumed my current position, I learned that the Office of Continuing Medical Education was about to undergo reaccreditation by the Accreditation Council for Continuing Medical Education (ACCME). This accreditation was to be under the newly adopted standards. The challenge was that with the closure of the hospital, most of our CME programs were no longer active. We established a team, conducted a self-study and refocused our CME attention on the community rather than exclusively on the faculty. In response, in July, 2009 we received full 4-year reaccreditation.

These three areas became models for the university. Additionally, our office played a critical role in the recent successful re-accreditation of the University by the Western Association of Schools and Colleges (WASC).

#### Teaching, Service and Research:

One of the most exciting aspects of my current position has been the opportunity to work with and mentor more junior colleagues and students across several disciplines. These efforts have resulted in numerous CDU presentations over the years at Association of American Medical Colleges, Western Group on Educational Affairs, and the Association for the Behavioral Sciences in Medical Education. Additionally, I have served as a research mentor to medical students on a variety of projects addressing health care disparities, and in 2009 was named the Mentor of the Year for the Medical Student Research Thesis Program. I have also worked with different junior faculty within the department (and outside the department) on their clinical research projects.

#### **Professional Activities and Leadership:**

I have been active in my professional associations at both the state and national levels. I have served in a variety of leadership positions as a committee member or chair, and in elected capacities. Currently I serve on the Group on Educational Affairs – CME Steering Committee for the Association of American Medical Colleges and just completed a term as Chair of the Committee on Honors for the American Speech-Language-Hearing Association.

#### **Summary**

An educational environment must focus on the students, and faculty are integral to student recruitment and retention and ultimately, learning, matriculation and graduation. Likewise, faculty excellence is also central to recruitment and retention of outstanding faculty peers who need committed support to achieve their goals and objectives. I have always believed that administrators and leaders must serve the faculty so that they may fulfill their individual teaching, creativity/scholarship and service responsibilities.
