1. Parking Garage

Final Certificate of Occupancy was received. Monumental Sign and stair design are pending.

2. Paving from University Drive to University Hall

It was confirmed that there will no additional spots for the CODS clinic. The gate is working but should be trimmed slightly to allow more clearance for pedestrians. The signs for the fuel efficient vehicles will be upgraded to provide greater clarity for electric vehicles or hybrids only. The trash enclosure is complete in the University Hall Lot.

3. Access Gate for Lot 8 – Hobart Hall

Capital Planning has been unable to come up with a plan to provide an access gate to Lot 8 at Hobart Hall. The challenges are related to providing enough queuing, with a bypass feature that does not eliminate a significant number of parking spaces. Capital Planning will revisit the design with assumptions for queuing of two cars

and no left turns into or out of the Lot.

4. Summer Paving Recommendations:

The Committee recommends paving the following locations during the summer recess of 2016:

University Drive between Lot 5 and Lot 6 exit
Dorm Road Drive between University Drive and Residence Hall Access Gate
Rec Center Drive between University Drive and Rec Center
Pioneer Road near Pioneer and Heritage Parking Areas
Revised ADA Striping at Lot 2
Additional Parking Space in University Hall Lot

5. Lot 5 Shuttle Bus Stop

The Committee requested that demand for a designated shuttle bus stop should be determined with Residence life before taking further action.

6. New Business

KG advised the committee of ongoing problems with the obsolete light poles on University Drive. These poles and the electrical feeds are over 40 years old and are failing. PPO is replacing the section between Lot 6 exit and West Overlook on University Drive. However, there are many others leading from Entry 6 to Pioneer and Heritage. Professional services will be required to prepare a design and bid documents.
