How to Apply for FEDERAL Aid and STATE using the FAFSA!

The state of New Jersey Higher Education Assistance Authority (HESAA) awards Tuition Aid Grants (TAG) to eligible New Jersey residents. In order to calculate a student's eligibility, the state requires students and parent(s) to complete additional information not found on the FAFSA.

Students will be asked if they are a veteran, the amount of Earned Income Credit for student or parent(s) and untaxed Social Security benefits for student or parent(s). If the answer is zero please do not leave the answer blank but write in a zero. After you submit the FAFSA, go to the **Confirmation Page**, then click **Start State Application Here** to start the State information section. Remember to turn off the pop-up blocker.

Eligibility Information

Based on the <u>eligibility criteria</u>, you may be eligible for the following:

Estimated Expected Family Contribution (EFC)

= 00524

The EFC is a measure of how much you can contribute to the cost of your education. Schools use your EFC to determine your federal student aid eligibility.

The EFC is <u>not</u> how much aid you will receive or how much you have to pay for college. Pell Grant Estimate - \$5,095.00

<u>Direct Stafford Loan</u> Estimate -\$9,500.00

You may also be eligible to receive other federal, state, or institutional grants, scholarships, and/or work-study.

In addition, you should learn about federal tax benefits for education, including the American Opportunity Tax Credit (AOTC).

You indicated that you had filed an IRS tax return when you provided your financial information and it appears that you were eligible to use the <u>IRS Data Retrieval Tool</u>, which allows you to view information from your IRS tax return and transfer that information directly into your FAFSA. The benefit of using the tool is that it's the easiest way to provide accurate tax information, and it also eliminates the need for providing a copy of your tax return to the financial aid office at your college. Once your FAFSA has been processed, you can return to *FAFSA on the Web* and use the tool to transfer your tax information.
