The Graduate Policy Council is proposing the following motion:

Due to on-going undergraduate enrollment challenges, growing graduate competition, and potential opportunities for building new revenue streams, the Graduate Policy Council proposes the creation of a "Graduate Studies, Development and Advisory ad hoc Committee" in order to develop and evaluate the feasibility and benefits of various models, programs, certificates, institutes and centers that can be established at William Paterson University as part of an integrated, cohesive and shared vision for undergraduate-graduate studies growth. This vision would complement and build on our undergraduate programs, promote both undergraduate and graduate program growth and enhance the quality, reputation and marketability of our programs, while providing additional revenue streams that support student success, program sustainability and institutional viability. In an environment of rightsizing and cost-cutting, we need to take proactive steps in order to achieve strategic growth and stability.

Proposal: Establish a "Graduate Studies, Development and Advisory ad hoc committee" This committee will evaluate the feasibility, economies and benefits of various models, metrics, programs, certificates, institutes and centers that can be established as part of an integrated, cohesive and shared vision for graduate studies that complements our undergraduate programs, enhances the quality of our programs and provides revenue streams that support growth.

Graduate Multicultural, Mentoring and Support (G-MMS) Program:

Propose to establish a program that promotes diversity and inclusiveness at this University and in so doing supports enrollment/retention, academic programs, advocacy workshops and social justice. The program would work with existing resources (e.g., Centers for Inclusion and

Diversity and the Black Cultural Center, Director: Yolany Gonell) in providing programs that further the goal of increasing diversity in our graduate and professional programs.

The "Virtual" Graduate Forum Spring 2021: Creating a shared vision Creating a shared, cohesive vision of graduate studies for developing programs, certificates, Institutes and Centers that increase University prestige, enhance graduate program and reach national and international communities.

Advisement Resource Tool:

Add an advisor attribute for graduate students so that faculty can track more efficiently a student's advisor.
