Priority Charges for AY2021-2022:

- 1) Assess the following UCC areas: Diversity and Justice & Area 3B: Historical Perspectives.
 - UCC Director Daria Napierkowski coordinated assessment efforts with department assessment coordinators. Results to be entered in Anthology (formerly Campus Labs) by the end of May.
- 2) Lead the UCC area committees in updating the Student Learning Outcomes for each core area to ensure they reflect current disciplinary language and include the goal of decolonizing the curriculum.
 - Co-chair Lynne Orr coordinated updating of the Student Learning Outcomes with the ten Review Panels. Recommended updates for most areas presented at the last Faculty Senate meeting. The following SLO Areas were updated:
 - i. Area 1 Personal Well-Being
 - ii. Area 3a Philosophical Perspectives
 - iii. Area 3b Historical Perspectives
 - iv. Area 3d Scientific Perspectives
 - v. Area 3e Quantitative Thinking
 - vi. Area 4: Diversity and Justice
 - vii. Writing Intensive
 - viii. Technology Intensive
- 3) Review and update, as needed, the UCC Student Learning Outcomes.
 - The Council did not address this charge.
- 4) In honor of the ten-year anniversary of the current UCC, develop a Renewal/Refresh plan. This might consist of: a celebration; updates (including but not limited to decolonizing the UCC); re-educating the WPU community (students, staff, faculty) about the goals of UCC; re-engaging faculty, staff, and advisors with professional development workshops; updating the webpage
 - Council members participated in the review/updating of learning outcomes for each of the areas. Re-engagement activities regarding the UCC were not addressed.
- 5) Examine the extent to which students are taking UCC courses within their own major rather than, as hoped, in a variety of disciplines and, as needed, plan for related updates.
 - Council was not able to address this charge.
- 6) Consider how students in WPOnline and ADC programs complete their core requirements.
 - Council was not able to address this charge.

• Recommended Charges for the Next Academic Year:

- 1) Assess the following UCC areas: Area Six: Global Awareness & Area 3A: Philosophical Perspectives
- 2) Complete the Area SLO updates for remaining areas and review the UCC Program SLO.
- 3) As part of a Renewal/Refresh Plan, develop and implement strategies to re-educate and reengage the university community in the UCC program, including performing an update of the UCC website.
- 4) Design and implement a strategy for course renewal to align with updated UCC area outcomes
- 5) Evaluate how skills and concepts such as Creativity, Critical Thinking, Public Speaking, and Ethics are or are not addressed in the UCC program.
- 6) Discuss and assess the role of Social Justice in the entire UCC program and consider the integration of the Social Justice Syllabus (Taylor, 2019).
