Friday, March 7, 2025

The meeting was called to order at 9:05 a.m. in the 1800 Valley Road Board Room. Trustees were both in attendance and participating via a virtual platform.

In accordance with the "Open Public Meetings Act," the Chairperson publicly announced and entered into the minutes that adequate notice of this meeting was provided. In compliance with the Statute, this notice was posted in advance on the University's web page and distributed to The Herald News, The Record, and The Star Ledger more than 48 hours prior to this meeting.

At approximately 10:50 a.m., the Public Session resumed.

Chair Michael Seeve welcomed everyone to the in-person and virtual meeting. He thanked members of the University community who have participated in the governance of the University by attending the Board meeting and reported that there was a request for public comment from Dr. Susanna Tardi.

Dr. Tardi addressed the board regarding her concerns.

Mr. Seeve acknowledged Dr. Tardi's comments. He then continued the meeting by reading the University's Land Acknowledgment statement.

APPROVAL OF MINUTES NOVEMBER 22, 2025 BOARD OF TRUSTEES MEETING:

The minutes of the November 22, 2025, Board Meeting were approved as distributed.

CHAIR OF THE BOARD OF TRUSTEES REPORT

Chair Michael Seeve stated that the Board Committees met on February 20, 2025, where issues were thoroughly discussed and vetted, and then were moved forward to the agenda for the full Board meeting. The Vice Presidents and others in the University community updated the Trustees on various

items. The Finance, Audit, and Institutional Development Committee met with Internal Auditor Ms. Olga Onetti, Chief Financial Officer Kirsten Loewrigkeit, and Chief Information Officer Gamin Bartle. They then heard reports from several Vice Presidents, including reports from the Chief Financial Officer, reviewed bid waivers, heard an update from Cabinet members on the implementation of the Strategic Plan, and reports from Enrollment Management and Institutional Advancement. The Educational Policy and Student Development Committee heard a presentation from Provost Powers on undergraduate and graduate enrollment trends, the growth of certificate programs, and other initiatives that support the retention of students. The Personnel and Compensation Committee considers mainly confidential matters.

Chair Seeve stated that Dr. Helldobler keeps the Board apprised of campus happenings and the accomplishments of faculty, staff, and students. The Board continues to carefully monitor enrollments and the budget as they plan for the university's future. He also stated that they are appreciative and are fully supportive of President Helldobler and his outstanding leadership and they look forward to continuing to work closely together. That concluded his report.

PRESIDENT'S REPORT

President Helldobler thanked Mr. Seeve for his support and that of the Board. President Helldobler stated that his full report is included in the meeting materials and summarizes recent accomplishments of the faculty, staff, and students since the last Board meeting. He noted that he is always happy to speak about such positive news and outcomes and encouraged everyone to read his full report.

He shared that William Paterson University just received a new designation as part of its Carnegie Class, Research College, and University based on the revamped institutional designation criteria. The University is one of just 86 institutions among the 325 institutions in our 'Masters Large College' classification, nationally, and one of only two public New Jersey institutions to receive this designation under the revamped classifications. Pivotal to the change is the expenditures that come from resources provided through grant and contract activities, which have tripled, much of which directly benefits the students and the community in some form. Dr. Helldobler thanked Provost Josh Powers for his leadership, and the many principal investigators, project directors, and campus support units, such as the Office of Sponsored Programs and the Budget Office, that have enabled this distinction.

The Cotsakos College of Business and the Association to Advance Collegiate Schools of Business International (AACSB) have announced that a recent peer review panel reaffirmed the College's status as an AACSB accredited undergraduate and master's level business program for the next five years. This is the fourth time the programs have been reaccredited since initial accreditation in 2005. The reaccreditation builds on the recent momentum of the College, which now ranks second in the state in both the number of MBA graduates and MBA program enrollment and offers the most affordable online program in New Jersey.

The New Jersey Office of the Secretary of Higher Education recently announced that William Paterson is one of only two institutions of higher education in the State, along with NJIT, to receive awards under the state's pilot Global Entrepreneurs-in-Residence (Global EIR) program. With a targeted focus on driving innovation and entrepreneurship in the field of generative artificial intelligence (AI), the program leverages WP's expertise to create pathways for international entrepreneurs to stay in the state to grow their startups by obtaining an H-1B visa through part-time academic roles where their-in-residence work alongside university stakeholders and strategic partners will advance research, mentor and teach students, and build and scale their startups. Congratulations to Provost Josh Powers, and regional

director of the New Jersey Small Business Development Center at William Paterson Melissa Rosario, and everyone across the campus who helped make this award happen and who will carry out its important work.

Dr. Helldobler congratulated Francisco Díaz, Associate Vice President for Student Development, who was named the recipient of two 2025 Mena Valdez Awards - the Outstanding Senior Student Affairs Officer Award and the Outstanding Service Award presented by the NASPA Student Affairs Administrators in Higher Education Latinx/a/o Knowledge Community. These awards recognize work done to advance the organization's success, provide leadership and guidance, and recognize those who are an inspiration to new student affairs professionals as well as serving as a mentor, with passion and dedication, advocating for the success of Latinx/a/o individuals in higher education and promoting the student affairs profession.

The University was awarded several recent grants. The National Institutes of Health (NIH) awarded a \$130,000 grant to the University for a two-year study on how women's biomechanics change during pregnancy, to be led by kinesiology Professor Jason Wicke and nursing Professor and alumna Samantha Rueter. Additionally, Associate Director, Professional Certificates & Training Ms. Quay Davis received funding from the N.J. Department of Labor and Workforce Development Fund to support Professional Certifications and Alternate Credentials/ CAPS at the following industries and amounts: Healthcare, \$246,400; Logistics & Distribution, \$240,000; Food and Beverage, \$215,460; and Finance, \$236,160.

President Helldobler reported that in student athletic news, the WP men's and women's swimming and diving teams both received the College Swimming and Diving Coaches Association of America (CSCAA) Scholar All-America Award for the Fall 2024 semester.

Lastly, he mentioned that he hopes everyone can join us next week, on Thursday, March 13, at 7:30 p.m. in the Shea Center, when Terry Gross, host and co-executive producer of the award-winning National Public Radio show *Fresh Air*, will speak as part of the Distinguished Lecturer Series. Since 1975, Gross has been conducting in-depth conversations exploring a wide variety of popular culture, news, and issues, setting the standard for long-form audio interviews. She will be interviewed by Alum Steven Baker, the former executive producer of ABC News' Nightline turned filmmaker and documentarian executive producer.

SPRING 2025 ENROLLMENT UPDATE

Vice President for Enrollment Management, George Kacenga, provided a Spring 2025 enrollment update. Dr. Kacenga presented a slide showing the Spring 2025 Enrollment Census I Projected Final. He highlighted the differences between Census II 2024 and Census I 2025. As of Census I, the University headcount is 10,052, the Undergraduate Headcount is 6,555, the Graduate headcount is 3,497, the main campus headcount is 5,743, the WP Online headcount is 4,309, the new student headcount is 1,541. Dr. Kacenga reported that for the first time since Spring 2017, Spring overall enrollment is over 10,000. Overall, Enrollment has increased by over 7%. Dr. Kacenga reported an 18.78% increase in applications and an 11.96% increase in acceptances. Year over year these numbers are trending up. Dr. Kacenga presented slides showing an enrollment forecast for Fall 2025, new student applications, enrollment imperatives, and understanding and influencing points for Fall 2025. Dr. Kacenga also highlighted the number of international students we enrolled and their countries.

GOVERNMENT AND COMMUNITY AFFAIRS REPORT:

Vice President de Veyga communicated that his full report is included in the board packet. Dr. de Veyga spoke in detail about the state budget and Governor Murphy's proposed \$58.5 billion budget, which includes a \$70 million reduction in outcome-based allocation funding. This budget adds a host of revenue raisers, including increased realty transfer fees and increased tax rates on sports betting, alcohol, adult-use marijuana, and cigarettes. Dr. de Veyga spoke briefly about local elections and also updated the Board on the executive order that is relevant to higher education and noted that he had included more details in his written report.

RISEPOINT PRESENTATION

Dr. Helldobler introduced Christopher Chiodo, Senior Vice President for University Partnership at Risepoint, formerly Academic Partners. Mr. Chiodo provided background on the organization and their acquisition with Academic Partners. He discussed how they work with university partners and support over 100,000 students. They work with over 1800 faculty members and support over 2000 programs. He began with a report that was presented to our staff in December 2024. The report detailed our strategic relationship, our growth plan, and their components. He reviewed our strategic plan overview, comparing the base and best-case scenario from 2024 to 2027. Mr. Chiodo stated that Risepoint believes we will have growth over the next three years in the online portfolio and growth in the portfolio of programs. He also reviewed new program projections by best case and potential case from 2026 to 2027. Mr. Chiodo presented a program optimization diagnostic showing the top recommendations as maintaining competitive pricing, maintaining accelerated time to completion, and ensuring the curriculum is aligned with career outcomes and their next steps. Mr. Chiodo ended his presentation with recommended actions, including strengthening core programs & elevating the student experience, optimizing processes and operations, and driving growth through expanded offerings.

EXECUTIVE COMMITTEE REPORT

Chief of Staff Loretta Mc Laughlin Vignier stated that the Executive committee met on December 10th, 2024, to take a single action, the approval of a waiver for the vendor Enrollment Advisory Group. Acting on behalf of the board, the bid waiver was approved.

FINANCE, AUDIT, AND INSTITUTIONAL DEVELOPMENT COMMITTEE REPORT:

Trustee Lenahan stated that the Finance, Audit, and Institutional Development Committee met on Thursday, February 20, 2025, with Internal Auditor Olga Onetti, Chief Financial Officer Kirsten Loewrigkeit, and with Chief Information Officer Dr. Gamin Bartle. He stated that they have continued their practice of meeting regularly with the chief information officer regarding cyber security risk assessment, and processes to ensure campus systems are protected. The committee heard several reports, including one from the external auditor Baker Tilly and the investment group JP Morgan. Presentations from the vice presidents included all funds report and bid waiver requests from the chief financial officer, and updates on university enrollment and retention, a strategic plan implementation update, and an institutional advancement report. The FAID Committee agreed to move the following resolutions forward to the full board for approval.

EDUCATIONAL POLICY AND STUDENT DEVELOPMENT COMMITTEE REPORT

Vice Chair John Galandak provided this report on behalf of Trustee Pesce. He began the report by stating that the committee also met on February 20, 2025, and heard presentations from several Cabinet members on enrollment and retention, and a strategic plan update. They also heard a report from Provost Powers that provided an important look back on enrollment trends since 2019 as well as information on initiatives that have supported student retention. He stated that there is a lot of positive news, and the administration and faculty are paying focused attention on continuing to increase student success measures in a variety of ways, including through developing certificates. In his comments, Trustee Pesce expressed confidence in the university's ability to succeed due to a more substantial foundation compared to a few years ago. He acknowledged the efforts and investments made during difficult times, which he believes demonstrate true leadership and have positioned the university for future success. He also praised everyone for their ability to adapt and change over the past few years.

Trustee Brad Neilley began his report by stating that the Personnel and Compensation Committee met on Thursday, February 20, 2025. They opened the meeting to all Board and Cabinet members included in personnel decisions. The committee heard reports from Cabinet members and the President concerning the Strategic Plan Update. He stated that the committee had a resolution, which is a consent agenda concerning various personnel matters. The committee examined materials provided by Human Resources and the President's Office regarding personnel decisions made since the last Board of Trustees meeting. The committee agreed to move the resolution forward for the full Board's consideration.

It was moved by Mr. Seeve and then seconded by Mr. Galandak to adopt the following resolution:

RESOLUTION 3-25-11, VARIOUS PERSONNEL MATTERS (CONSENT AGENDA)

The resolution was unanimously adopted.

President Helldobler invited the faculty members in the audience who had recently been promoted and awarded tenure to stand and be acknowledged. They were then congratulated.

NOMINATIONS AND GOVERNANCE COMMITTEE

Vice Chair John Galandak stated that the Nominations and Governance Committee met on Thursday, February 20, 2025. The Committee received an update from Vice President de Veyga on local government elections and pending bills in the state legislature that could affect higher educational institutions. He stated that the committee had no motions to move forward to the full board for approval.

OTHER BUSINESS:

Chair Seeve thanked all the committee chairs and notified all that the next Board meeting will take place on Thursday, June 19, 2025.

Hearing no other business or comments, the meeting was adjourned at 11:50 am.

PRESIDENT'S REPORT
TO THE WILLIAM PATERSON UNIVERSITY BOARD OF TRUSTEES
RICHARD J. HELLDOBLE, Ph.D.
MARCH 7, 2025

I hope 2025 is going well for everyone. With the Spring semester approaching the halfway mark, campus is in full swing with students working toward Spring Break, beginning March 17.

The flurry of executive orders and other directives coming from Washington have raised a lot of questions in terms of their potential impact on William Paterson and our students. As Vice President for Strategic Initiatives and University Relations **Guillermo de Veyga** informed the Board committees during their Feb. 20 meetings, we are keeping a close watch on these developments. I have communicated this same message to our campus community, including in a Feb. 24 email to students, faculty, and staff, in which I also wrote: “A lot of unanswered questions remain for the courts to sort out. What should not be in doubt, however, is William Paterson University’s commitment to educating and supporting our students the best way we know how. We are proud of our diverse academic community and recognize it for its great strength. Implicit in that recognition is a professional – and I believe a moral – obligation to support the specific needs of every student and every faculty and staff member, and that is what we will continue to do. So, while the administration, our congressional representatives, and the courts work out what these orders will ultimately mean, we will keep moving forward, learning and teaching, supporting our students, and supporting one another. Let’s keep doing the work!”

The Carnegie Foundation, working with ACE, revamped its institutional designation criteria, and I’m pleased to share the news that William Paterson University just received a new designation as part of its **Carnegie Class – Research College and University**. We are one of just 86 institutions among the 325 institutions in our ‘Masters – Large College’ classification, nationally, and one of only two public New Jersey institutions to receive this designation under the revamped classifications. This designation is tied to expenditures that come, in substantial part, from resources provided through grant and contract activities, which have tripled, from approximately \$4 million in 2018 to more than \$12 million in revenues today. Thanks to Provost **Josh Powers** for his leadership, as well as to the many principal investigators, project directors, and campus support units, such as the **Office of Sponsored Programs** and the **Budget Office**, that have enabled this distinction. Importantly, much of this grant/contract activity directly benefits our students and our community in some form.

The William Paterson community kicked off **Black History Month** celebrations early with its annual celebration of the powerful legacy of **Dr. Martin Luther King, Jr.** The **MLK Day of Service** on January 24 saw approximately 150 students, faculty, and staff participate in service projects on campus and at five community, educational, and social service sites throughout our surrounding community, which ultimately impacted thousands of people in need. The day is a wonderful example of the kinds of civic engagement activities and hands-on service learning that are essential to the William Paterson experience.

William Paterson University has launched an innovative, expanded experiential learning model designed to give every student the opportunity to obtain a significant hands-on experience that will prepare them for success in the job market following graduation. **The Career Experience Program**, a collaboration between the Career Development Center and the Division of Academic Affairs, is required for all students beginning with this year's first-year students who will graduate in 2028. The comprehensive program, unique among those at New Jersey public institutions, offers students a variety of ways to fulfill the requirement. Options range from coursework in a student's major that includes a hands-on project, fieldwork, or a civic engagement experience, to opportunities outside class such as an internship, job simulation, job shadowing, or faculty-led research project, among other options. A majority of students will be able to complete the requirement through the curriculum of their major. The program is part of the University's strategic and holistic approach to student support, designed to prepare them for college and beyond. All new students are paired with a student success team of experts and mentors who stay with them through graduation, including a career coach. Career development begins in the first semester.

The New Jersey Office of the Secretary of Higher Education (OSHE) recently announced that William Paterson is one of only two institutions of higher education in the State, along with NJIT, to receive awards under the state's pilot **Global Entrepreneurs-in-Residence (Global EIR)**

program. With a targeted focus on driving innovation and entrepreneurship in the field of generative artificial intelligence (AI), this economic development initiative leverages WP's and NJIT's expertise to create pathways for international entrepreneurs to stay in the state to grow their startups. The Global EIR program provides a unique pathway for entrepreneurs to obtain H-1B visas through part-time academic roles. In these roles, entrepreneurs-in-residence work alongside university stakeholders and strategic partners to advance research, mentor and teach students, and build and scale their startups. This comes following an analysis by the National Foundation for American Policy finding that nearly two-thirds of the top AI companies in the U.S. were founded or co-founded by immigrants and 70 percent of full-time graduate students in fields related to AI are international students. Congratulations to Provost **Josh Powers**, as well as **Melissa Rosario**, regional director of the New Jersey Small Business Development Center at William Paterson, and everyone across the campus who helped make this award happen and who will carry out its important work.

William Paterson University's new '**50 Alumni Under 50**' program shines a light on Pioneer alumni who embody the mission and values of the University. These remarkable alumni are having a meaningful impact and demonstrating the many ways that a William Paterson degree is a springboard to success in their careers, communities, and lives. STUDENT NEWS

A team of seven William Paterson University students placed in the **top 5 percent** of more than 4,800 teams in this academic year's **National Cyber League (NCL) Cybersecurity Competition**. The student-competitors are majors in computer science or information technology. Providing participants with real-world cybersecurity challenges, the competition is designed to help students develop and demonstrate their skills. Over the course of three days, students face off on issues in open-source intelligence, cryptography, password cracking, log analysis, network traffic analysis, web application security, and forensics. The high-performing WP team consisted of students from the University's Networking Club: **Divine Dickson-Uwakwe**, **Mia Herrera**, **Wilton Lizardo**, **Bibek Neupane**, **Amaury Polanco**, **John Sam-Bruce**, and **Amil Uddin**. Computer Science **Professor Kiho Lim**, the Networking Club advisor, served as the team's coach.

FACULTY NEWS

William Paterson University Art History **Professor Claudia Goldstein** has just published her second book, titled *Beuckelaer and the Art of Dining: Northern Painting, Food, and Social Class in Early Modern Italy*. Through it, Goldstein hopes to share an understanding and appreciation of a little-researched artist while also dismantling some of the "artificial barriers" in art history, she says. Joachim Beuckelaer was a Flemish painter who specialized in large-scale paintings of food markets and kitchen scenes, popularizing the still life genre. Though his work often focuses on

peasants and working classes, Beuckelaer boasted a rather wealthy, exclusive clientele both in Belgium and Italy that included nobility.

The Deadline Club, the New York City chapter of the Society of Professional Journalists (SPJ), has elected William Paterson University professor **Nicholas Hirshon** as its president for 2025, the group's centennial year. The Outstanding Senior Student Affairs Officer Award is presented to a senior student affairs officer who has provided advice and energy to the Latinx/a/o Knowledge Community that advanced the organization's success, provided leadership and guidance, and has been an inspiration to new student affairs professionals. The Outstanding Service Award recognizes the dedication and service of a NASPA member in promoting the profession of student affairs, students, and the Latinx/a/o Knowledge Community overall, serving as a mentor and exuding a passion and dedication to advocating for the success of Latinx/a/o individuals in higher education.

The flurry of executive orders and other federal directives with the potential to impact higher education was a significant topic of conversation at the **American Council on Education's ACEx2025 conference**. I traveled to Washington, D.C. to participate in these important conversations and to meet with some of our elected representatives. William Paterson is fortunate to have many strong advocates for public higher education representing our district and our state as we confront a new higher education landscape in the coming months and years. While in Washington, I also had the honor of receiving the Council of **Fellows/Fidelity Investments Mentor Award**. As I said in my acceptance remarks, I would like to think that being honored with this award due to my mentoring work demonstrates my continued gratitude to the many mentors and colleagues who helped me along the way. I am proud that the WP community has welcomed the ACE Fellows we have hosted in recent years and has long embraced a culture of mentorship, including through powerful initiatives like the Pesce Family Mentoring Institute and the ACE Women's Network.

Congratulations to my fellow honorees, and thanks to **ROI-NJ** for again including me on their [**"ROI Influencers Power List 2025"**](#) for Higher Education. This is ultimately a reflection of the great work being done by our excellent faculty and staff across the University.

NEW SPONSORED RESEARCH AND GRANTS

The **National Institutes of Health (NIH)** has awarded a \$130,000 grant to William Paterson University for a two-year study on how women's biomechanics change during pregnancy, to be led by kinesiology **Professor Jason Wicke** and nursing Professor and alumna **Samantha Rueter, '12, DNP '23**. Using the Human Research Motion Lab at William Paterson, of which Wicke is director, he and Rueter will scientifically capture changes to the size of women's bodies over the course of pregnancy. They will then analyze how those changes affect the women's movement. Wicke and Rueter's research project was selected for a NIH grant from among a national pool of universities and institutions.

Nursing **Professor Lydia Albuquerque** was awarded \$52,380 from the N.J. Department of Health to support the project, *Virtual Peer Support PLUS Fitbit to increase Physical Activity*.

Associate Director, Professional Certificates & Training **Quay Davis** was awarded funding from the **N.J. Department of Labor and Workforce Development Fund** to support Professional Certifications and Alternate Credentials/ CAPS at the following industries and amounts: Healthcare, \$246,400; Logistics & Distribution, \$240,000; Food and Beverage, \$215,460; and Finance, \$236,160.

The **WP men's and women's swimming and diving teams** both received the **College Swimming and Diving Coaches Association of America (CSCAA) Scholar All-America Award** for the Fall 2024 semester.
