**MEETING OF THE BOARD OF TRUSTEES OF
THE WILLIAM PATERSON UNIVERSITY OF
NEW JERSEY**

Friday, November 21, 2025

The meeting was called to order at 9:01 a.m. in the 1800 Valley Road Board Room. Trustees were both in attendance and participating via a virtual platform.

ANNOUNCEMENT CONCERNING ADEQUATE NOTICE OF MEETING:

In accordance with the "Open Public Meetings Act," the Chairperson publicly announced and entered into the minutes that adequate notice of this meeting was provided. In compliance with the Statute, this notice was posted in advance on the University's web page and distributed to The Herald News, The Record, and The Star Ledger more than 48 hours prior to this meeting.

It was moved and seconded to adopt the following resolution:

At approximately 10:45 a.m., the Public Session resumed.

Board Chair Michael Seeve welcomed everyone to the in-person and virtual meeting. He thanked members of the University community who participated in the governance of the University by attending the Board meeting and reported that there were no requests for public comment.

APPROVAL OF MINUTES SEPTEMBER 19, 2025, BOARD OF TRUSTEES MEETING:

The minutes of the September 19, 2025, Board Meeting were approved as distributed.

GREAT FALLS COMMUNITY CENTER REPORT

Chair Seeve noted for the record that Trustee Bob Guarasci was not in attendance for this portion of the meeting. Pursuant to New Jersey conflict of interest law, and the Uniform Ethics Code, Trustee Guarasci, who serves as the Chief Executive of the New Jersey Community Development Corporation (NJCDC), has recused himself from any and all William Paterson University matters that affect a potential collaboration with the NJCDC and the University's role with the Great Falls Youth and Recreation Center in Paterson. Trustee Idida Rodriguez also recused herself and disconnected from the call.

President Helldobler presented an overview of the University's proposed collaboration with the Great Falls Community Center. The Board of Trustees approved the following resolution:

Trustees Guarasci and Rodriguez rejoined the meeting.

ANNUAL CLERY REPORT

The Director of Public Safety and University Police, Charles Lowe, provided an overview of the University's compliance with the Clery Act, including statutory requirements, annual reporting obligations, and recent crime statistics. He outlined the federal mandates governing crime data collection, classification, and disclosure, as well as requirements for timely warnings, emergency notifications, missing student procedures, and fire safety reporting. The report summarized three years of campus crime data, VAWA-related offenses, arrest and referral trends, and hate crime incidents. The overview included a comparative analysis of key crime categories across peer institutions. Mr. Lowe concluded the presentation by highlighting upcoming reporting changes, including the addition of hazing statistics beginning in October 2026.

CHAIR OF THE BOARD OF TRUSTEES REPORT

Chair Seeve reported that the Board Committees met on November 6, 2025, to receive updates from Vice Presidents and other university leaders and to thoroughly review key issues before advancing them to the full Board agenda. The Finance, Audit, and Institutional Development Committee met privately with Chief Financial Officer Kirsten Loewrigkeit, Chief Information Officer Gamin Bartle, and Internal Auditor Olga Onetti before hearing reports on strategic planning, enrollment, and advancement. The Educational Policy and Student Development Committee received a presentation on Rise Point, while the Personnel Committee addressed confidential personnel matters. The Nominations and Governance Committee reviewed revisions to the Board's Emeritus Status policy.

The Board also completed the President's annual assessment, approving a salary increase and a merit bonus in alignment with his contract, with full Board support. Trustees expressed appreciation to those who contributed feedback during the evaluation process, noting that the insights complemented the President's performance indicators and annual goals. Trustees commented on the President's work over the past year.

PRESIDENT'S REPORT

President Helldobler's report highlighted the University's progress over a challenging year and emphasized that its successes result from the collective efforts of faculty, staff, and leadership. Key updates included major campus events such as the annual scholarship luncheon, recognition of outstanding students, and the groundbreaking for the new Sports and Health Sciences Center. The President reported significant achievements, including two newly awarded TRIO grants totaling \$2.7 million, national recognition of the University's music and entertainment industries program, and honors received by members of the University community.

The report concluded with a heartfelt recognition of Vice President for Institutional Advancement Pamela Ferguson on her retirement. Trustees, President Emerita Kathleen Waldron, and colleagues commended Ms. Ferguson's transformative leadership, exceptional donor stewardship, and major

contributions to scholarship growth, fundraising, and alumni engagement. The Board conferred upon her the honorary title of Vice President for Institutional Advancement Emerita.

ENROLLMENT UPDATE

Vice President for Enrollment Management George Kacenga provided an enrollment update highlighting the gap between the University's aggressive enrollment goals and the significant growth achieved despite external challenges. While several targets were not met, the institution saw strong year-over-year increases across most categories. Overall headcount grew 6.25% to 12,527 students, marking the University's highest enrollment since 1980, and noted that the current student population reflects a more diverse mix of main campus, online, dual enrollment, and international students.

Undergraduate enrollment increased by 5.76%, graduate enrollment 4.17%, main campus 4.7%, and WP Online 6.34%. High school dual enrollment saw a nearly 30% increase. Degree-seeking enrollment grew modestly overall, though main campus degree-seeking students declined 2.58%, and is a major priority for improvement. International enrollment was a notable strength, increasing 18.23% even as first-time international enrollment declined nationally. However, visa and geopolitical issues will continue to affect short-term projections, with Spring applications down compared to last year. The University currently enrolls 238 international students from 54 countries, contributing to classroom diversity.

The report also compared Census 1 and Census 2 data, showed strong gains driven by WP Online second-session enrollments and expanded dual enrollment partnerships. Mid-summer projections were revised to account for anticipated declines in international and nursing program enrollment.

Looking ahead to Spring 2026, the University expects:

- Slight overall decline (0.35%) of main campus enrollment due to larger graduating cohorts.
- More than 6% growth in WP Online undergraduate and graduate programs.
- Overall combined growth of approximately 2.5%.

The report concluded with confidence in continued upward trends, tempered by realistic expectations around international enrollment.

GOVERNMENT AND COMMUNITY AFFAIRS REPORT

Associate Vice President for University and Government Relations Carol Cuadrado reported key federal and state updates affecting higher education. The 43-day federal government shutdown ended on November 12. Federal agencies have resumed processing student aid, research grants, and program oversight, though significant backlogs remain. Ongoing budget uncertainty for FY 2026 and reliance on short-term continuing resolutions pose potential risks to federal funding streams for institutions like William Paterson.

The Department of Education's 2025 negotiated rulemaking (NEGREG) process is advancing major regulatory changes through three committees—RISE, PSLF, and AHEAD. These reforms will impact financial aid eligibility, borrowing limits, accountability standards, and reporting requirements, with implementation expected in July 2026. Institutions may need to adjust academic programs, financial aid operations, compliance practices, and student advising to meet the new regulations.

Regarding the November 2025 elections, Mikie Sherrill won the gubernatorial race, and she selected Dale Caldwell as her lieutenant governor. The reelection of the District 35 Team, including Senator Benjie Wimberly and Assemblyman Al Abdelaziz, was highlighted. Kenyatta Stewart was elected for the first time in the assembly; all are William Paterson alumni.

AVP Cuadrado also gave a capital funding and legislative advocacy update.

The OPM bills (Senate Bill 4818 and Assembly Bill 5990) were successfully pulled from the Senate Higher Education Committee agenda after meetings with legislators and the sponsor.

AVP Cuadrado has been very actively engaged in coordinating the reappointment of our Board of Trustees members, all of whom have been officially and formally re-nominated by Governor Phil Murphy.

She noted that recent campus events have enabled the University to host numerous legislators, including during the Fieldhouse opening and the major groundbreaking ceremony attended by Congresswoman Pou and Secretary of State Tahesha Way.

UNIVERSITY STRATEGIC PLAN 2022-2025 UPDATE

Vice President for Marketing and Public Relations Stuart Goldstein stated the Board of Trustees' committees were fully briefed on updates to the 2022–2025 Strategic Plan between October and November. Substantial progress continues to be achieved across all strategic pillars. Detailed reports for each pillar are documented in the Board of Trustees Committee meeting minutes. Pillar reports will be published on the University website.

UNIVERSITY STRATEGIC PLAN 2026-2031 PLANNING UPDATE

President Helldobler and the Dean of the College of Education, Dr. Amy Ginsberg, provided an update on the new strategic plan, with progress being made on all frames and full reports available in the Board of Trustees committee meeting minutes. The university has a new website for the strategic plan, with extensive involvement from university members to orient the campus community to the process, participants, and five strategic frames. Listening sessions were held across campus divisions, including with the Student Government Association, to gather input for the strategic plan. The University is emphasizing a competitive edge and leveraging external data to ensure a realistic plan. The planning effort involves broad representation, including a 37-member Central Committee and working groups composed of faculty, administrators, and a student trustee. Extensive engagement has occurred through in-person and virtual listening sessions, student government meetings, advisory councils, and a university-wide survey with strong student participation.

The plan aims to position the university for long-term academic, financial, and reputational strength through an inclusive, evidence-based five-year roadmap. Early themes emerging include strengthening the student experience, expanding high-demand academic programs, aligning resources more effectively, and deepening external partnerships. Work is ongoing, with proposed strategic directions expected in January, refinement by March, and a final plan targeted for board endorsement in late spring.

FINANCE, AUDIT, AND INSTITUTIONAL DEVELOPMENT COMMITTEE REPORT:

Committee chair Kevin Lenahan stated that the Finance, Audit, and Institutional Development Committee met on Thursday, November 6, 2025. Prior to that meeting, the Committee met privately with the Internal Auditor, Ms. Olga Onetti, and Chief Information Officer Gamin Bartle to discuss university risks, internal audit reports, and other items the Committee should be aware of. Mr. Lenahan also stated that the committee heard from external auditors Baker Tilly, who reported an unmodified opinion on the financial statements for June 30, 2025. Mr. Lenahan thanked the auditors, Ms.

Loewrigkeit, and her team for all their hard work. The committee approved two resolutions to move forward for the full board's consideration:

EDUCATIONAL POLICY AND STUDENT DEVELOPMENT COMMITTEE REPORT:

Committee Chair Trustee Pesce reported that the committee met on November 6, with presentations on enrollment, Strategic Plan updates, and Rise Point.

Associate Provost Dr. Jonathan Lincoln presented information regarding new certificate programs: an undergraduate certificate in artificial intelligence literacy and ethics, and a graduate certificate in Emergency Management as part of the Master's in Public Policy program. The committee approved the following resolutions:

PERSONNEL AND COMPENSATION COMMITTEE REPORT:

Committee Chair Trustee Brad Neilley stated that the Personnel and Compensation Committee met on Thursday, November 6th. They opened the meeting to all Board and Cabinet members included in personnel decisions. The committee heard reports from Cabinet members and the President covering the Strategic Plan. The committee approved the following resolution:

NOMINATIONS AND GOVERNANCE COMMITTEE

Committee Chair and Board Vice Chair John Galandak stated that the Nominations and Governance Committee met on Thursday, November 6th. The committee reviewed revisions to one board policy and agreed to move it forward to the full Board for approval.

RESOLUTION 11-25-8, ON THE REVISIONS TO THE BOARD POLICY ON EMERITUS STATUS
The resolution was unanimously adopted.*

Mr. Galandak thanked the Chief of Staff, who coordinated this review, and the members of the Nominations and Governance Committee for their work in making sure that the Board policies are up to date.

OTHER BUSINESS:

President Helldobler noted the retirement of Associate Provost Dr. Sandy Hill. Among her accomplishments is the number of 2+2 and 3+1 pathway opportunities significantly expanded under her leadership. Dual enrollment was previously minimal, as reflected in the data that has been shared. The Office of Sponsored Programs reports to Dr. Hill, and their enterprise has grown from \$3 million to \$14 million, including the two recently awarded TRIO grants. Dr. Helldobler thanked Dr. Hill for her work and for the tremendous growth and wished her a happy retirement.

Dr. Helldobler thanked all the committee chairs and, on behalf of the Board, wished everyone a happy and safe Thanksgiving holiday.

Hearing no other business or comments, the meeting was adjourned at 12:33 pm.

11-25-2 A RESOLUTION OF THE BOARD OF TRUSTEES OF THE WILLIAM PATERSON UNIVERSITY OF NEW JERSEY APPROVING AND AUTHORIZING THE UNIVERSITY TO FUND ONE MILLION DOLLARS FROM ITS UNRESTRICTED RESERVES FOR USE IN A COMMUNITY CENTER IN THE CITY OF PATERSON, NEW JERSEY; AND AUTHORIZING OFFICERS OF THE WILLIAM PATERSON UNIVERSITY OF NEW JERSEY TO TAKE ALL ACTIONS DEEMED NECESSARY FOR THE COMPLETION ON THAT TRANSFER AND INVESTMENT

WHEREAS: The Board of Trustees (the “Board”) of the William Paterson University of New Jersey (the “University”) recognizes the importance of the University’s relationship with the City of Paterson and has prioritized increasing WP’s presence in the community; and

WHEREAS: The Board values opportunities for WP students to engage in cocurricular programs beyond the campus and is aware of the wealth of potential collaboration with the Community Center in the City of Paterson; and

WHEREAS: In furtherance of the Board’s priorities and values, it desires to approve allocating \$1 million from the University’s unrestricted reserves to assist with the funding of a community center in the City of Paterson, New Jersey; and

WHEREAS: The University shall work with the developer of the center on branding and establishing a college hub for the students of Paterson, which will include the University’s name and information; and

WHEREAS: No agreement will be completed without review of the University’s administrative and legal team, and ensuring that the terms and conditions of the agreement align with the University’s strategic goals as well as the University’s naming policy; therefore, be it

RESOLVED: That the Board of Trustees of the William Paterson University of New Jersey authorizes the University to transfer up to \$1 million from its unrestricted reserves to fund a community center in the City of Paterson, New Jersey.

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE WILLIAM PATERSON UNIVERSITY OF NEW JERSEY APPROVING AND AUTHORIZING THE REFUNDING OF ALL OR A PORTION OF THE NEW JERSEY EDUCATIONAL FACILITIES AUTHORITY'S REVENUE BONDS, THE WILLIAM PATERSON UNIVERSITY OF NEW JERSEY ISSUE, SERIES 2015 C and 2016 E BONDS; APPROVING THE FORM OF AND AUTHORIZING THE EXECUTION AND DELIVERY OF A LEASE AND AGREEMENT AND ALL OTHER NECESSARY DOCUMENTS; AND AUTHORIZING OFFICERS OF THE WILLIAM PATERSON UNIVERSITY OF NEW JERSEY TO TAKE ALL ACTIONS DEEMED NECESSARY OR DESIRABLE IN CONNECTION WITH THE BONDS TO BE REFUNDED

WHEREAS: The Board of Trustees (the "Board") of the William Paterson University of New Jersey (the "University") desires to approve the current refunding of all or a portion of the New Jersey Educational Facilities Authority's outstanding Revenue Bonds, The William Paterson University of New Jersey Issue, Series 2015 C and 2016 E (the "Refunded Bonds") through the issuance of new refunding bonds by the New Jersey Educational Facility Authority (the "Authority") in an amount not to exceed \$85,000,000 (the "Bonds") (the "Refunding Project"); and

WHEREAS: The Series 2015 C and 2016 E Bonds were issued in the original aggregate principal amount of \$106,450,000. Proceeds of the 2015C Bonds were used to (i) the current refunding of all of the Authority's outstanding Series 2005 E Bonds, (ii) to finance the renovation, acquisition, installation and construction of certain capital improvements to the University's facilities and (iii) the payment of certain costs incidental to the issuance and sale of the Series 2015 C Bonds. Proceeds of the 2016E Bonds were used to (i) advance refund all of the Authority's outstanding Series 2008 C Bonds and (ii) the payment of certain costs incidental to the issuance and sale of the Series 2016 E Bonds; and

WHEREAS: The Board wishes to refund all or a portion of the 2015 C and 2016 E series in order to achieve debt service savings through the issuance by the Authority of the Bonds in one or more series and bearing interest at such rates and maturing on such dates as determined by the Authorized Officers; and

WHEREAS: The University has determined that the Bonds will be secured by a Lease or Loan Agreement and/or other such agreements or instruments necessary (collectively the "Agreement") pursuant to which the University will be obligated, inter alia; to pay annual debt service in an amount sufficient to satisfy the Authority's debt service obligations with respect to the refinancing; and

WHEREAS: The Board desires to authorize certain officers of the Board and the University to approve the form of and execute and deliver the Agreement, and all other documents and to take any and all action necessary to implement the Refunding Project and the financing thereof and all costs related thereto; therefore, be it

RESOLVED: By the Board of Trustees of the William Paterson University of New Jersey as follows:

Section 1. The Board hereby approves and authorizes the undertaking and implementation of the Refunding Project with a minimum threshold of \$1 million in aggregate gross savings; and

Section 2. The Board hereby approves and authorizes the financing of all or a portion of the costs of the Refunding Project, including the costs of issuance and other related costs. The Authorized Officers (as hereinafter defined) are hereby authorized and directed, in consultation with the Authority, the financial advisor and the bond counsel to determine the structure and method of sale that is most advantageous to the University.

Section 3. The Board Chairperson, the Board Vice-Chairperson, the Board Secretary, the President, the Vice President for Finance and Administration and Chief Financial Officer (the "Authorized Officers"), are hereby authorized and directed to execute, deliver and approve any and all agreements, documents, certificates, directions and notices, including (without limitation), a trust indenture, a bond insurance commitment, a bond purchase agreement, and an escrow letter of instructions, and to do and perform such acts and to take such other actions as may be necessary or required or which the Authority may deem to be appropriate to undertake, implement and finance the Refunding Project, including the costs of issuance and other related costs and to effectuate the execution and delivery of the Agreement and any other documentation necessary to effectuate the undertaking, implementation and financing of the Refunding Project. Any Authorized Officer is hereby authorized and directed, for and on behalf of and in the name of the University, to attest and deliver said documentation and to affix the seal of the University to said documentation as applicable; and

Section 4. All resolutions, orders and other actions of the University in conflict with the provisions of this Resolution to the extent of such conflict are hereby superseded, repealed or revoked; and

Section 5. This Resolution shall take effect immediately.

11-25-5 RESOLUTION, ON THE INITIATION OF CERTIFICATES

Included for Committee review are the following personnel actions and a resolution approving the various personnel actions taken by the University.

a. Fall 2025 Graduate Assistantship Appointment

Academic Affairs has provided a list of continuing and new Graduate Assistantships, along with a list of graduate students whose assistantships have ended, either due to the completion of their graduate studies or for other reasons. The costs vary for these positions and cannot be simply enumerated.

b. Various Personnel Matters

The spreadsheet shows personnel matters at the University that have been affected since the last Board Meeting on September 19, 2025, including appointments, temporary appointments, promotions/reclassifications, resignations, retirements, and salary changes.

Administrative and Faculty Appointments

Since the Board of Trustees last met, the University has made ten administrative hires. They include two Assistant Directors, one Director, two Non-Tenured Track Teaching Professionals, and five Professional Services Specialists.
